I just wanted to check in with you regarding this site.

If you recall, last fall several new monitoring wells were installed at this site, and we are under direction to sample the new wells quarterly for one year, and then revert to a semi-annual sampling program for all wells. Last quarter, we were able to access all of the wells, however, during this quarter, we have been unable to make contact with all property owners.

There will likely be a well or two skipped during this event, because of a lack of access.

Secondly, I wanted to know if you have had a chance to read the FS/CAP report from August 3rd, and if you had any questions about the content/recommendations presented.
