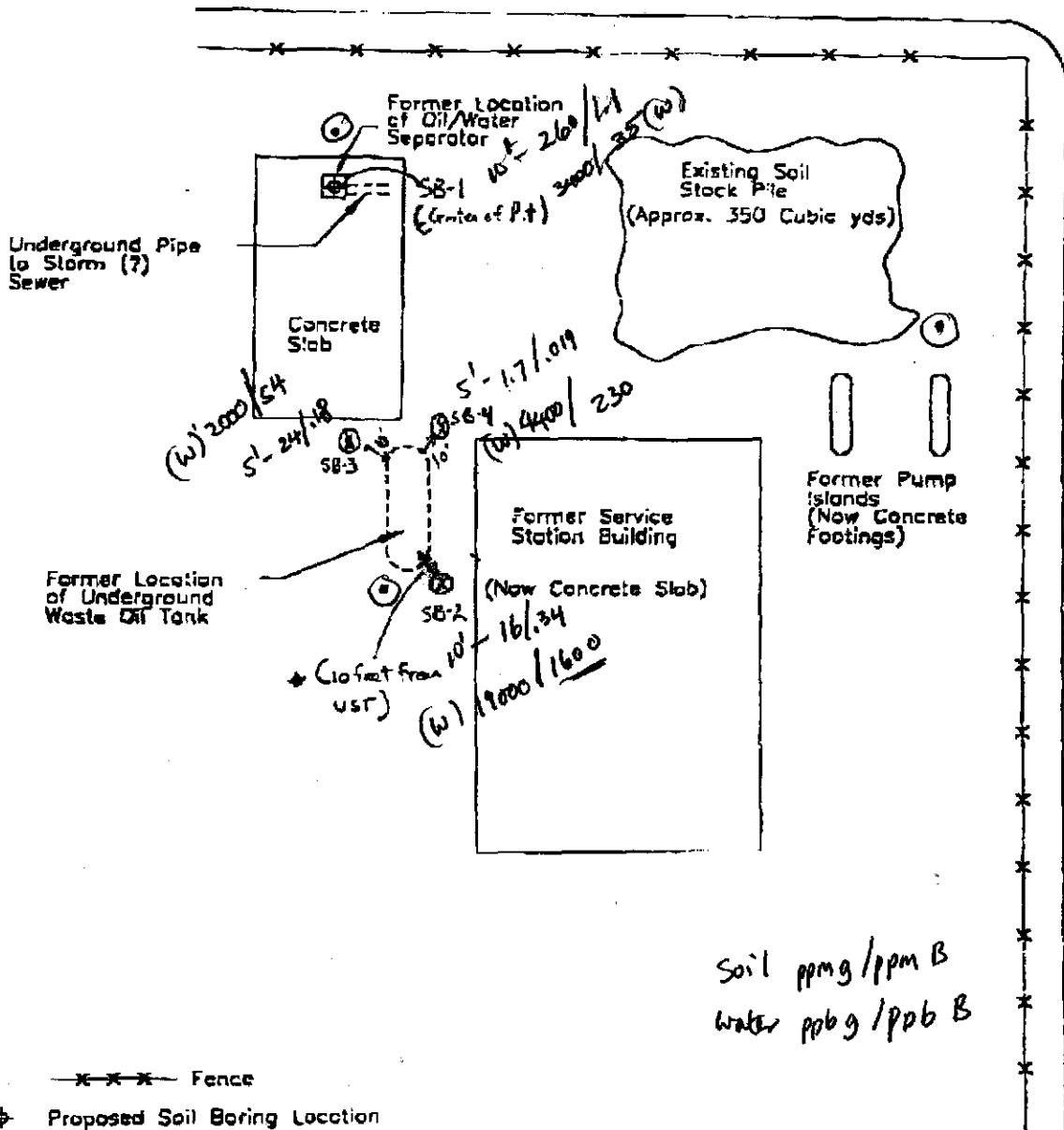

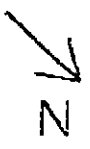


HEGENBERGER ROAD
