Apparently we've been having a few problems, but close the Food Inspection popup. You should also see a LOP Document popup that is smaller (sometimes behind the food one, sometimes above it); open that one, and then you can search within that one. Last week I had to use the entire case number, rather than the short cut (RO0000185 vs. 185), but you can also search by address, etc. Keep trying if at first it doesn't work, it should eventually...

Mark,

As you may recall, I talked with you on September 26 re the above Fuel Leak case. I represent the adjoining land owner, Matin Moghadam.

The last information that I have is of Chevron's Site Assessment Work Plan received by the County on September 17, 2012. I don't know if there has been any subsequent communications between Chevron and the County as I'm having difficulty again finding the file on the ACEH website. Can you please send me the link to this site on the County website? That would be appreciated as it seems to be more complete than Geotracker.

In looking at the September 17 Chevron submittal, we are very concerned that they have not provided the FS/CAP requested by the County. While I have read their rationale for not yet submitting the FS/CAP, this case has been investigated for at least eight years with no or little remediation/cleanup. This is clearly to the detriment of my client as MW-4 located on his property consistently shows significant levels of TPH & Benzene.

We hope that you are looking carefully at this submittal and will move the actual remediation along as best that you can. Your work is appreciated.
