Hi Ardi.

It is good to hear that you have made progress on the water well and a location. The lack of a response to our August 29, 2017 directive letter to you is the one item that has largely stopped work at the site. Due to the lack of a response for over one year, ACDEH has been considering moving the case towards closure as a vacant property, with no development. The cleanup of vacant sites is not required to be as stringent, and much higher levels of contamination can be left in the ground safely. Such a letter notifying you and your stakeholders of this due to the lack of a response for over a year, is on my to do list for the site, but is late. I will attempt to prioritize this. I want to make sure you are aware, if you are still planning to develop the site in the near term, ACDEH must receive written responses from you to that effect. As you are aware without water the site is not developable. It is very important that if you have identified a well location and have found good water, then you must let everyone know by providing a report that identifies the location, state that the water flow is sufficient for the development, and must provide the results of the analytical testing, at a minimum. This is the written response ACDEH is requesting just above.

In regards to a meeting, one is not currently scheduled and Dilan is out through next week. I think it best if you provide the report requested above to all, and then it would make some sense to have the meeting as there will have been a change in the status of the development and case. I'm not sure if you are aware, but Carryl MacLeod has been transferred off the site and a new Chevron case manager, Shelby Lathrop, has been assigned to the case for Chevron. A meeting would also provide a chance for everyone to meet Shelby.
