Dear Ms. Shipley:

Alameda County Environmental Health (ACEH) is reviewing the fuel case file for the above referenced site for potential case closure. Site investigation and groundwater monitoring from underground storage tank leaks have been performed at the subject property to which you are named as the primary or active responsible party. Pursuant to Section 25297.15 (a), ACEH, the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACEH is required to notify the primary or active responsible party of their requirement to certify in writing to the local agency with a complete mailing list of all record fee title owners. If Livermore Unified School District is the sole property owner, please complete item 2 of the List of Landowners Form.

To satisfy the above-mentioned requirement, please complete the enclosed "List of Landowners Form," and mail it back to ACEH within thirty (30) days from the date of this letter. Also your comments must be considered prior to the proposed cleanup or closure. Please respond within 30 days from the date of this letter for your comments to be considered.

Public participation is a requirement for the Corrective Action Plan and case closure process. Following review, if case closure is considered acceptable by ACEH, we will prepare at a future date a Draft Notification of Potential Case Closure to notify potentially affected members of the public of the potential fuel leak case closure. At that time, we will request that you submit a mailing list that includes residents and landowners in the surrounding area and any other interested persons, corporations, or government agencies you are aware of that may have an interest in this fuel leak case. Upon receipt and review of the mailing list, ACEH will request that you distribute the Notification of Potential Case Closure to the mailing list. ACEH will consider all comments from the public prior to potential case closure.
