Hello Jerry, Unfortunately we still don't have a completed encroachment permit to install the additional well. The RP has been out of the country (China) for the past couple months and has not been able to sign off on the permit. I've been working with the RP to see if he can sign and have the permit notarized (as required by the City of Oakland) at a US Embassy in China. The closest US Embassy to the RP is a three hour flight away and scheduling an appointment has been problematic according to the RP. Once we have the encroachment permit, we should be ale to proceed without much further delay, but it looks like we might not have this resolved until the RP gets back to the US in late March 2012. On behalf of the RP I'm requesting another extension. I apologize for the continued delays, but unfortunately my hands are tied until we get the encroachment permit resolved.
