Dear Mr. Hill:

This is a notice of an enforcement referral for the subject site. The site Responsible Party is non-responsive to Alameda County Environmental Health (ACEH) requests and is recalcitrant. The site has accumulated a series of Notice of Violations from ACEH. As a consequence, ACEH is referring this site to the San Francisco Bay Regional Water Quality Control Board for enforcement actions.

Site Background

A waste oil tank was removed from the site, and several holes were observed in the tank at the time of its removal. Stained odiferous soil was observed below the tank. Soil sample was reported to contain up to 3,900 milligrams per kilogram (mg/kg) total recoverable petroleum hydrocarbons (TRPH), and volatile organic compounds (VOCs) were also detected. The lateral and vertical extent of contamination is undefined and potential impacts to groundwater unevaluated.

ACEH requested a soil and groundwater investigation (SWI) due by November 20, 1996 and an SWI work plan due by May 21, 2000. None were submitted. In July 2008, ACEH requested the site be claimed in GeoTracker. ACEH issued Notices of Violation (NOV) on July 24, 2009 and on February 25, 2011 requesting report submittal and GeoTracker compliance. There has been no response.
