Pursuant to our discussion today, the contractor may continue construction work in the area of the former UST that was discovered on 6/10/16. Response to this UST was performed according to the 10/29/15 Construction Soil and Groundwater Management Plan. The analytical results for the soil sample collected beneath this UST indicate that a release did not occur. Accordingly, Langan (working on behalf of the owner and the UST removal contractor) and the ACEH LOP will contact Rob Weston of the CUPA to request a UST closure letter.

A map relating the location of the discovered UST to features at the former Connell automobile dealership was sent to the ACEH on 6/10/16. This tank was south of the dealership service bay, and proximal to monitoring well MW-2. This UST was not located near the dealership USTs. The dealership USTs were located under the sidewalk adjacent to Hawthorne Avenue and were removed in 1989. The fuel release from the dealership USTs did not affect the area near the UST discovered on 6/10/16. Based on the location and construction of this tank, we suspect that it may have been associated with St. Mary's school. The school operated at the property until the late 1920s.

Construction will continue on Monday 8/1/16, and Langan will provide the following additional documentation:

- Documentation relating the location of the discovered UST to historical Connell dealership site features
- Documentation relating the location of the discovered UST to historical St. Mary's school features
- The additional documentation will be provided in the Completion Report for the Connell LUFT case, currently anticipated for October 2016
- Issue an errata sheet to address the typographic errors to personnel titles in Section 3.1 of the UST Removal Report
