Alameda County Environmental Health (ACEH) staff has reviewed the case file including Section 5.3, *Soil Vapor and Groundwater Well Destruction* of the Draft *Construction Soil and Groundwater Management Plan* (CSGMP) dated July 24, 2015 and prepared and submitted on your behalf by Langan Treadwell Rollo (Langan). Thank you for submitting the CSGMP. Due to the accelerated construction schedule, we understand that all of the site groundwater and soil vapor wells will be decommissioned during the month of August 2015, consequently, based on ACEH staff review of the work plan, the proposed scope of work of Section 5.3, *Soil Vapor and Groundwater Well Destruction* is conditionally approved for

of Section 5.3, Soll Vapor and Groundwater Well Destruction is conditionally approved for implementation provided that the technical comment below is incorporated during the proposed work. Submittal of a revised work plan or a work plan addendum is not required unless an alternate scope of work outside that described in the work plan or these technical comments is proposed. We request that you address the following technical comments, perform the proposed work, and send us the report described below. Please provide 72-hour advance written notification to this office (e-mail preferred to: karel.detterman@acgov.org) prior to the start of field activities.

TECHNICAL COMMENTS for Section 5.3, Soil Vapor and Groundwater Well Destruction:

- 1. Wells to be Decommissioned, Table 1 and Figure 2: ACEH understands that off-site well MW-13 will not be decommissioned, yet it is listed with the wells to be decommissioned. Please clarify the wells to be decommissioned in August 2015.
- 2. Containment of Groundwater Displaced from Wells during Decommissioning Process: Please ensure that groundwater displaced from wells during the decommissioning process is captured and containerized prior to, during, and following the decommissioning process. ACEH is in agreement that fresh water should be used to make the cement grout, due to elevated groundwater concentrations in some wells. Completed and signed manifests or bills of lading, profiling and disposal documentation should be included in the *Well Decommissioning Report* described in Section 5.12, *Completion Report*.
- 3. Drill Cuttings Disposal Documentation: Completed and signed manifests or bills of lading, profiling and disposal documentation should be included in the *Well Decommissioning Report* described in Section 5.12, *Completion Report*.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.
