Alameda County Environmental Health (ACEH) staff has reviewed the case file including the Draft *Construction Soil and Groundwater Management Plan* (CSGMP) dated July 24, 2015 and prepared and submitted on your behalf by Langan Treadwell Rollo (Langan). Thank you for submitting the Draft CSGMP. Section 5.3, *Soil Vapor and Groundwater Well Destruction* of the Draft CSGMP was conditionally approved in ACEH's July 29, 2015 e-mail Directive Letter.

Based on ACEH staff review of the Draft CSGMP and discussions during our September 3, 2015 meeting, the draft CSGMP is conditionally approved for implementation provided that the items discussed in our meeting and the technical comment below is incorporated into the Final CSGMP.

TECHNICAL COMMENT for the CSGMP:

1. Subsurface Demolition, Equipment Removal, and Unknown/Unexpected Conditions Regulatory Oversight: According to Mr. Rob Weston, Senior Hazardous Materials Inspector of ACEH's Certified Unified Program Agency (CUPA), because the business in not in the CUPA Program, CUPA would not provide oversight, however, ACEH will provide the oversight of unexpected conditions since it is an active LOP case. As a contingency measure, please include a section describing the removal, confirmation sampling, disposal, and documentation of unknown underground storage tanks (USTs), vaults, piping, and/or other buried objects. ACEH must be notified prior to the removal(s) and the work must be approved by ACEH.

This report is being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.
