The only document they have posted is the May 2010 Site Management Plan (a copy of which I think you already have). The post next to the document link on the webpage says the document has not yet been reviewed. This comment was written when the doc was loaded. I know they've reviewed and approved it. Looks like they just haven't updated the page (changing that notation or uploading more recent documents).

If you need anything more describing their oversight let me know. But if you were just looking for evidence that this was a DTSC file the information on the Envirostor page should suffice (it says it's a DTSC VC site and identifies the staff assigned to its oversight).

Regarding the questions from the City Manager et al, there are several Wareham projects under way in Emeryville. City staff are in frequent communication with Wareham (as they are with other developers/occupants/residents) on a variety of issues. In meetings with Wareham occasionally the uncertainties of the regulatory process at sites are spoken of as concerns. When they are the City Manager asks the Director of Economic Development to look into whatever these concerns might be. That's when they come to me. Being a bit removed from the front-line, Wareham doesn't have a sense of the process or timing of your review of what's been submitted. That's the uncertainty here.

So that's why I try to stay current on what's going on. So that when somebody stops by my cubby and says "what's going on with EmeryStation" I can have the answer. It's been a couple of weeks since anyone has asked, but I feel a question is on the horizon.

Did Treadwell give you a package of information that answers the questions? I type with crossed fingers that they did.
