Dear Mr. and Ms. Lum and Victor Lum:

Alameda County Environmental Health (ACEH) is reviewing the fuel case file for the above referenced site for potential case closure. Site investigation and groundwater monitoring from underground storage tank leaks have been performed at the subject property to which you are named as the primary or active responsible party. Pursuant to Section 25297.15 (a), ACEH, the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACEH is required to notify the primary or active responsible party of their requirement to certify in writing to the local agency that the notification requirement in the above-mentioned regulation has been satisfied and to provide the local agency with a complete mailing list of all record fee title owners.

To satisfy the above-mentioned requirement, please complete the enclosed "List of Landowners Form," and mail it back to ACEH within thirty (30) days from the date of this letter. Also your comments must be considered prior to the proposed cleanup or closure. Please respond within 60 days from the date of this letter for your comments to be considered.

Public participation is a requirement for the case closure process. In order to notify potentially affected members of the public of the proposed action, a Notification of Potential Case Closure fact sheet will be distributed to nearby landowners and residents as well as any other interested persons. Therefore, we request that you review the attached Draft Notification of Potential Case Closure fact sheet and provide comments to ACEH requesting changes to the Fact Sheet or concurrence that the fact sheet is acceptable **no later than February 20, 2013**. Attached is a mailing list consisting of nearby landowners and residents and other known interested parties. We also request that you submit a mailing list **no later than February 20, 2013** of any persons, corporations, or government agencies you are aware of that may have an interest in this fuel leak case but are not included on the attached list. Upon finalization of the fact sheet, ACEH will distribute the fact sheet to landowners, residents, and any other interested parties. The Notification of Potential Case Closure requests that landowners or residents submit any comments or questions to ACEH regarding potential case closure. ACEH will consider all comments from the public prior to potential case closure.

In order to expedite the closure process, you may schedule well decommissioning for one to two weeks after the end of the public comment period. If public comments require a longer period of time for responses, it may be necessary to postpone well decommissioning.

DRAFT NOTIFICATION OF POTENTIAL CASE CLOSURE Vic's Automotive Service February 13, 2013


Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case at Vic's Auto automotive repair facility located at 245 8th Street in Oakland, California (see attached map on back). The site was previously a gas station and automotive repair facility equipped with seven underground storage tanks (USTs). The seven USTs were removed from the property in June 1993 and August 1994. After the 1994 UST removal, a 13,000-gallon UST was installed in the northern corner of the site. Surrounding land use is mixed residential and commercial

Site investigation activities to define the extent of petroleum hydrocarbons in soil and groundwater have included exploratory borings for soil and groundwater sampling, groundwater monitoring well installation and sampling, and soil gas sampling. A 16-day High Vacuum Dual Phase Extraction (HVDPE) pilot test was conducted from July 11 to July 27, 2005. During the pilot test, a total of approximately 1,716 gallons of gasoline was removed. Further HVDPE remediation was conducted using a fixed remediation system from June 2007 to June 2011 using both onsite and offsite wells. In 2010, air sparging was added to the HVDPE system. The remediation system removed an estimated 5,663 gallons of gasoline.

Soil and groundwater data indicate that a plume containing dissolved petroleum hydrocarbons is present beneath the site and likely extends southwest from the site. Following site cleanup, the plume appears to be decreasing in size and residual petroleum hydrocarbons in soil and groundwater are expected to biodegrade over time. The site has been evaluated in accordance with the State Water Resources Control Board Low-Threat Closure Policy. The groundwater plume and residual petroleum hydrocarbons in soil and groundwater are expected to biodegrade over time. Site investigation and cleanup activities have been completed and it does not appear that the fuel release presents a risk to human health for nearby residents or site workers. Therefore, ACEH is considering potential closure of the fuel leak case.

Next Step – The public is invited to review and comment on the potential closure of the fuel leak case. The entire case file can be viewed over the Internet on the ACEH website (http://www.acgov.org/aceh/lop/ust.htm) or the State of California Water Resources Control Board GeoTracker website (http://geotracker.swrcb.ca.gov). Please send written comments to Jerry Wickham at the address below; all comments will be forwarded to the responsible parties. **Comments received by April 22, 2013** will be considered and responded to prior to a final determination on the proposed case closure.
