Dear Trustees:

Alameda County Department of Environmental Health (ACDEH) has been made aware of several requests for access to your property in order to sample groundwater monitoring wells associated with the subject fuel leak case. The requests were made by the Responsible Party(ies) for the subject fuel leak case and/or by their environmental consultants. We understand that these access requests have been unsuccessful.

As you are aware, two groundwater monitoring wells associated with the subject fuel leak case are located on your property. These wells are an integral part of the well network used to monitor the potential off-site migration of contaminants in groundwater from the fuel release(s) that have occurred at the subject site. Therefore, ACDEH requests that you permit the Responsible Party(ies) and/or by their environmental consultants access to the wells.

Additionally, ACDEH has requested the Responsible Party conduct a soil vapor investigation to evaluate the potential risk posed by volatilization of petroleum hydrocarbons and fuel constituents. Two of the soil vapor sampling points in the work plan approved by our agency are located in your parking area, adjacent to the building located at 3923 Broadway.

As your property is a commercial establishment, conducting the field activities can be scheduled during offhours to minimize the impacts to your business.
