Got a note that the referenced EDF submittal (#2039725065) for site RO206 was denied. The reasoning was the 4<sup>th</sup> quarter 2007 report does not appear to be uploaded. To clarify, this EDF was for an oxygen injection confirmation GW sampling event we did in 12/07. This was not a formal GWM event; those were done during Q1 and Q3 of 2007 (site is semi-annual) and the associated reports are on GeoTracker. I believe the source of the confusion was that my admin included "4Q07" in the subject EDF name. Hopefully this will clarify the situation and allow this EDF to be accepted.
