At this time, ACEH will not grant an extension for report. This site has significant soil and groundwater contamination on and off-site and the UST Clean-up Fund's 5-Year review also concurs with that assessment (see attachment). At this time, implementation of site characterization and/or cleanup at this site is crucial to be protective of human health and the environment and to move this case towards closure evaluation. Please note that the Responsible Parties are required by California Code of Regulations, Title 23, Division 3, Chapter 16, Article 11, §2720 through §2728 to characterize the site and implement corrective action. Please note that site characterization and/or cleanup is not contingent upon receiving reimbursement monies from the UST Cleanup Fund.

Hi Lalji,

Paresh wrote a letter dated August 20, 2010 where he said he wanted the report documenting the installation and testing of the wells by November 18, 2010. This well installation and testing work scope was what the recently submitted UST Fund pre-approval request was for. Since we might not see the UST Fund approval for about a month, I recommend that we contact Paresh and let him know that by the time the UST Fund approves the costs we will be into the rainy season and water levels in the ground will be elevated. We do not want to do our feasibility study when the water levels are elevated. I recommend that we install the wells some time between now and July 2011, and that the feasibility test be performed some time after the beginning of July 2011. Please let me know if that is acceptable to you, and if I am authorized to contact Paresh with this request. Thank you!
