I don't know the status of the Desert Petroleum site. Donna Drogos is the case worker for the Desert Petroleum site across the street. I have forwarded your message to her.

With regard to the PCE detections in the area, I am attaching a map from some spilt sampling and a map put together by Colleen Winey at Zone 7 in case you don't already have these. PCE was also detected in the purge water disposal samples from the Desert Petroleum site.

We had requested decommissioning of well MW-1 but we can have the well left in place until your case is resolved.

Thanks for putting me in the loop on this. This site has an active SCP case, though since redevelopment has been pushed back, we have been in a waiting mode (hoping the results for the Desert Petroleum clean-up across the street might help direct onsite clean-up). I see no significant reasons for concern with closing the UST aspect of the case. We can always re-address any unforeseen issues under the SCP case.

With that in mind, can you tell me the status of Desert Petroleum? Also, since there has been some PCE detections noted in the BV report (from an unidentified off-site source), do you have more information on the extent of PCE in the immediate vicinity?

Our understanding and Bureau Veritas's understanding is that the Water Board will deal with the environmental issues other than USTs under your SLIC case.
