Dear Mr. Carlton:

This letter was prepared by Bureau Veritas North America, Inc. (Bureau Veritas) on behalf of Bordoni Ranch LLC and Green Valley Corporation Tenancy in Common (BGTIC) for the Groth Brothers Chevrolet facility located at 57-59 South L Street, in Livermore, Alameda County, California (the "Site" – Attachment 1, Figure 1). In a letter dated August 30, 2007, the San Francisco Bay Regional Water Quality Control Board (SFRWQCB) stated that the Water Boards are required to involve the public in site cleanup decisions under state law and that the board staff is increasing its efforts to provide public participation of its site cleanup programs. The SFRWQCB has requested the assistance of BGTIC as part of this effort with the items presented below, which are followed by a response.

"Specifically, you are required to submit a report by September 30, 2007, that includes a mailing list for surrounding property owners and resident/occupants within a 500-foot radius of the subject site ("radius list"). The mailing list should also include any other interested parties or groups, including relevant public agencies and environmental/community groups"

BGTIC has prepared a "radius list," which is included as an attachment to this letter. The "radius list" consists of 419 properties within a 500-foot radius of the Site (Attachment 3). The "radius list" includes the applicable assessors parcel number (APN), property owner, property address and current mailing address for each property owner.

"You are also requested to provide us with a draft notification for the subject site by the same date cited above. The draft notification should contain the following information:

- ***adequate information about the release and any site investigation, risk assessment, and interim remedial actions***
- ***description of pending technical reports and next steps***
- ***contact information for responsible party/parties and the Water Board***

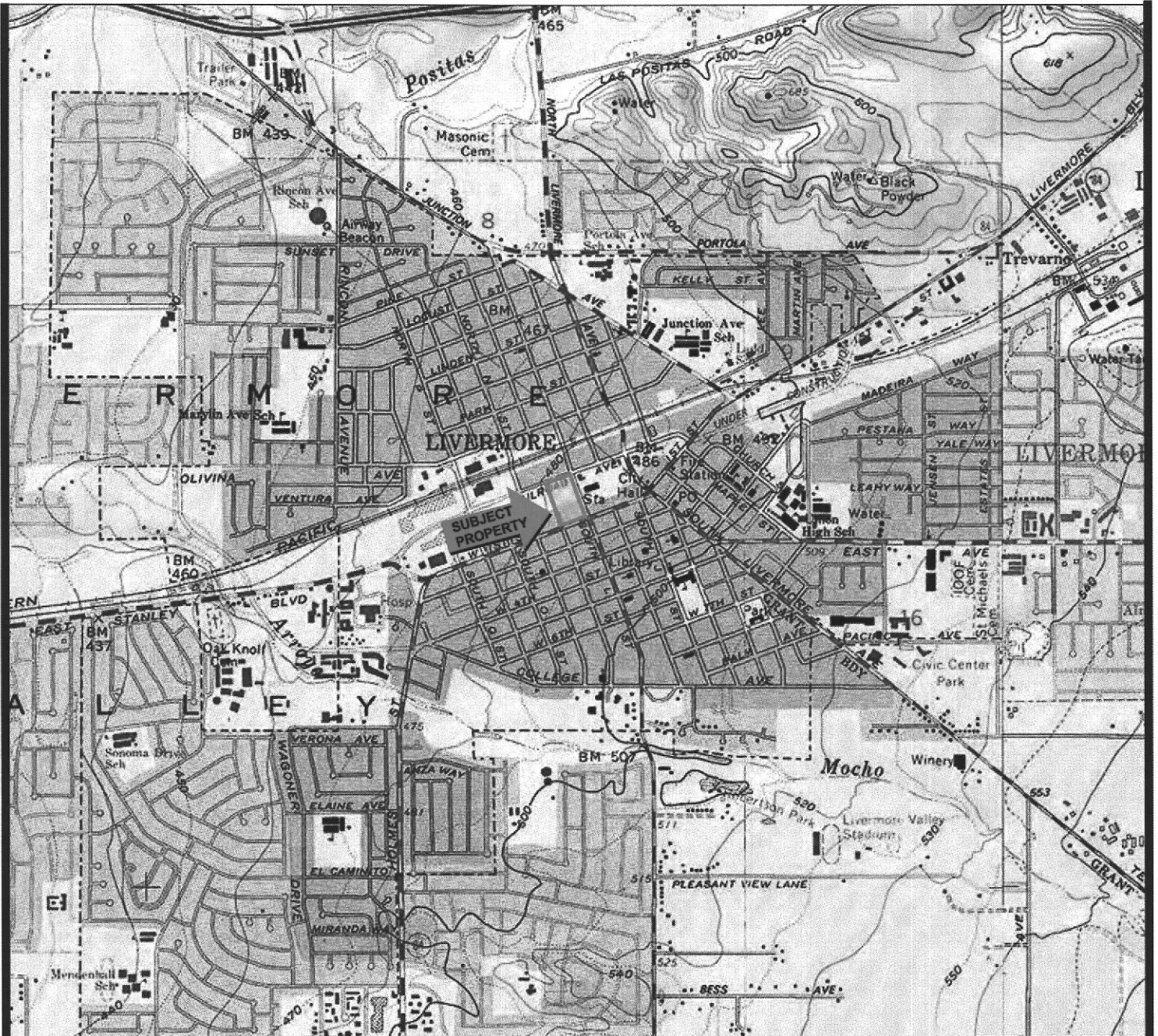

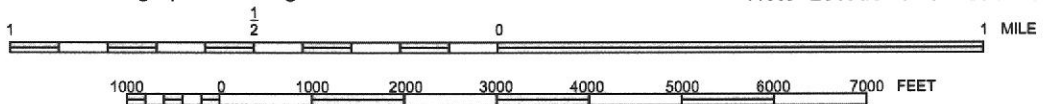

SITE BACKGROUND

The Site is located at 57-59 South L Street within the downtown portion of the City of Livermore, which is primarily zoned as industrial and commercial. The Site is currently developed as a new and used auto dealership operated by Groth Brothers Chevrolet (Groth) and contains four buildings including an auto showroom, automotive service area, an auto body shop containing a paint booth and paint mixing room, and a used car sales offices containing an auto detailing and a wash rack. The remaining areas of the Site consist of asphalt-paved parking areas.

Historically, the Site has been developed for a mix of residential, commercial, and industrial activities since at least 1884. Railroad tracks crossed the northern portion of the Site from at least 1884 through the 1970s. Land use on the southern portion of the Site has included a number of retail facilities as well as a fuel and feed shop, print shop, gasoline service stations, and automobile repair and service shop. Properties in the surrounding area have been developed since the 1880s for mixed commercial and residential use, including gasoline stations, auto repair and dry cleaning facilities.

SITE INVESTIGATION AND REMEDIATION

The Site is located immediately down-gradient of the Valley Gas Petroleum (Valley Gas) facility, which is an underground storage tank (UST) release currently under the regulatory oversight of the Alameda County Environmental Health Services (ACEHS). Currently, an Environmental Remediation Agreement is in place to remediate the Valley Gas property. Several off-site investigations associated with the Valley Gas petroleum hydrocarbon release have been performed and include investigations on the Site.

Petroleum hydrocarbons including benzene, toluene, ethylbenzene and xylene (BTEX) compounds, methyl tert-butyl ether (MTBE), total petroleum hydrocarbons (TPH) and naphthalene have been identified in the groundwater beneath the Groth Site. The concentrations of petroleum hydrocarbons are above applicable California Department of Health Services (DHS) primary MCLs or San Francisco Bay Regional Water Quality Control Board (SFRQWCB) Environmental Screening Levels (ESLs). The petroleum hydrocarbons detected in the groundwater beneath the Site are associated with the up-gradient Valley Gas facility.

Additionally, groundwater beneath the Site contains concentrations of chlorinated volatile organic compounds (VOCs) including tetrachloroethene (PCE) and its' associated daughter compounds including trichloroethene (TCE), cis-1,2-dichloroethene (DCE), trans-1,2-DCE and vinyl chloride. The detected concentrations of chlorinated VOCs are above primary MCLs and/or ESLs. The origin of these chlorinated VOCs is likely from an off-site and up-gradient release.

Total lead and arsenic have been detected above ESLs in the near surface soils at the Site. The extent of these soils appears limited to the shallow soils within the northwest portion of the Groth Site. In addition, low-level petroleum hydrocarbons were detected in soil in the vicinity of the repair shops. The extent of these petroleum hydrocarbons appears limited.

NEXT STEPS

Currently, Valley Gas is performing a pilot study to evaluate the effectiveness of treating and remediating the associated off-site and on-site groundwater contamination. Based upon the findings of the pilot study, a remedial action plan will be developed and implemented to address the proposed planned redevelopment of the Site for mixed commercial and residential use. Additionally, excavation of near surface soils may take place as part of re-development activities at the Groth Site, which will address the associated near surface soil contamination at that time.

WATER BOARD OVERSIGHT PROCESS

The Water Board oversees more than 3,000 site cleanup cases in the Bay Area, including more than 2,000 leaking fuel tank cases. Water Board staff direct investigation or cleanup work and set cleanup standards under Water Code authority. Responsible parties (e.g., property owners or past operators)

propose specific measures, perform the actual work, and submit technical reports documenting task completion. As part of this process, we circulate key documents, such as draft cleanup plans, to interested persons and provide an opportunity for comment on these documents. Interested persons include other agencies, local officials, non-profit organizations, and interested landowners and residents/occupants in the Site vicinity.

1.1 PROJECT SIZE AND LOCATION

The Project Area, as illustrated in Figure A, encompasses approximately 189 acres along the southeastern edge of the City of Long Beach, that was recently annexed from unincorporated Los Angeles County into the corporate limits of the City of Long Beach.

Pacific Coast Highway — primarily a commercial strip — forms the western boundary of the property, along with the Market Place Shopping Center and Shopkeeper Road. The Project Area is bisected into northern and southern portions by Westminster Avenue. At the northerly edge, three relatively small, triangular-shaped parcels, formerly landfill sites, are separated from the larger parcels by the Los Cerritos Channel and Loynes Drive.

Landmarks in the area include the San Gabriel River to the south of the site, and Los Cerritos Channel to the north, Alamitos Bay/Marine Stadium and the communities of Belmont Shore and Naples to the west, and Edison Company's Regional Electrical Generating Plant to the east.

The Project Area has been extensively developed for oil production facilities that date back to the 1920's, and has been significantly affected by the construction of major adjoining roadways, as well as the diking, filing, and channelization of the San Gabriel River and Los Cerritos Channel.

Two landfills were historically operated within the area. The Studebaker-Loynes Landfill consists of two sites — one a triangular parcel north of the Los Cerritos Channel, the other a narrow rectangular parcel along Studebaker Road. The second landfill, the Market Place Landfill, is located in southern portion of the property, east of Coast Highway and north of the San Gabriel River.
