Alameda County Department of Environmental Health (ACDEH) staff has reviewed the case file for the subject site. In our letter dated January 4, 2017, our agency conditionally approved the document entitled *Interim Remedial Action Workplan Addendum* (WPA) dated December 9, 2016 prepared by Geocon Consultants, Inc. (Geocon) for the subject site. Geocon submitted a correspondence, dated February 2, 2017, indicating they agreed to the conditions of our WPA authorization. However, as ACDEH did not specifically authorize WPA implementation, no documents have been submitted to either the ACDEH FTP or the State Water Resources Control Board's (SWRCBs) GeoTracker websites indicating WPA execution.

Therefore, ACDEH requests a meeting at our offices on **June 24, 2018 at 1:00PM** to discuss the case status and the path forward.
