Hi Jerry,

This email is a follow up to our phone conversation this morning regarding site assessment activities at 800, 726, and 706 Harrison Street in Oakland (Fuel Leak Case No. RO0000231, RO0000321, and RO0000484). As discussed, I am taking over ARCADIS project management of this site, my contact information is listed at the bottom of this email. Also, as discussed, we are requesting an extension for the Site Assessment Report Addendum from December 20, 2011 to "60 days after completion of field activities".

Revised locations GP-9 and GP-10 are located in City of Oakland Property requiring an Access Agreement. ARCADIS is coordinating with the City's Real Estate Department. Approval from the City's Environmental Department (required prior to initiating Access Agreement activities) was received at the end of last week. Though we are making good progress, we do not anticipate executing an access agreement in time to complete site assessment activities prior to the upcoming Holiday season. Pending procurement of an access agreement, we anticipate scheduling site assessment activities for the end of January. Due to the contingent nature of this event, we are requesting a due date tied to completion of field activities.
