It was great speaking with you yesterday. As discussed, a Progress Update and Extension Request Letter was submitted on February 15, 2017 and is attached. There were delays in getting the system installed before February 2017 because of the time needed to coordinate and secure the AS/SVE equipment to be used at the site, negotiate the change in location of the equipment and finalized access agreement property owner at 706 Harrison Street, coordinate with subcontractors on the revisions.

Based on the progress, a revised schedule is as follows:

March 8 – Submittal of final engineering plans to City of Oakland Building Department as part of the building permit application. Permit may take up to 8 weeks to approve

May 8 – Start of construction once permit is received. Construction is estimated to take approximately 6 weeks.

June 19 – Construction complete and system shakedown

June 26 – Start normal system operation
