

Monitoring Well Destruction for Fuel Leak Case No. RO0000241, BP #11127 5425 Martin Luther King Jr. Way, California

Dear Toan V. Nguyen:

ARCADIS submitted an application for Case Closure for the former BP site #11127, located at 5425 Martin Luther King Jr. Way, in Oakland, California, to Alameda County Environmental Health (ACEH) on August 6, 2010. A Case Closure indicates that all remediation has been completed and the site no longer poses a threat to human health or the environment. Part of the site closure entails destruction of all onsite monitoring wells. Destruction is completed by overdrilling the existing monitoring well and filling the open borehole to grade with neat cement grout (i.e, it will be flush with the asphalt surface). ARCADIS is planning to destroy the onsite wells within the next 2 months.

Additionally the application for Case Closure requires that "all current record owners of fee title to the site of the proposed action be notified of the proposed action by the primary or active responsible party". The purpose of this correspondence is to notify you of the proposed site closure and subsequent monitoring well destruction at the Site. To document that you have been notified of case closure and monitoring well destruction activities, ARCADIS request that you sign item # 2 on the attached form, List of Landowners Form, and return the form in the self-addressed-stamped-envelope within 30 days of receiving this letter.
