Alameda County Department of Environmental Health (ACDEH) staff has reviewed the fuel leak case file for the above-referenced site including the most recently submitted document entitled, "First Semiannual 2017 Groundwater Monitoring Report," (Report) dated April 30, 2017 and prepared by Stellar Environmental Solutions, Inc. on your behalf. The Report presents results from the groundwater and surface water sampling event conducted on March 20, 2017 including measuring static water levels in all 12 site groundwater monitoring wells and, collection and analysis of groundwater samples, and collection and analysis of surface water samples from Redwood Creek.

The Report recommends preparation of a work plan to treat residual soil contamination in the upland area beneath the former underground storage tank (UST) excavation to reduce the contaminant mass that is providing a source of contamination to groundwater and surface water.

ACDEH would like to schedule a meeting with you and your consultant to discuss the recent groundwater and surface water sampling results and the proposed remedial action and proposes the following potential dates and times frames for the meeting:

- Friday July 14, 2017 between 3 and 5 pm
- Tuesday August 1, 2017 between 10 am and 12 pm or 1 pm and 3pm
