Barbara,

We have requested access from Geotracker, but will not get access until the authorization form is submitted and approved.

However, I don't think we will be able to upload any EDFs once we get authorized for the Site. We would have to contact Northgate, Kleifelder, and the other previous consultants to see if they even have the EDFs and then upload the field points and then EDFs for each investigation. If they don't have the EDFs, I don't think the labs would regenerate the EDFs for a different consultant.

We will discuss this with Caltrans and have them ask their previous consultants to provide them the EDFs or direct them to allow us to request the data directly from the laboratories.

We'll let you know what develops.

This email is a follow up to our telephone conversation of this morning. Stantec has just recently obtained a copy of the February 27, 2012 Northgate *Soil Vapor Testing Report*, which you have indicated knowledge of, but have not reviewed. The Northgate scope of work was performed as per their June 2, 2011 *Soil Gas Sampling and Analysis Plan*, and did not address any of the technical comments in your September 9, 2011 *Work Plan Denial* letter.

Therefore, as you've requested, Stantec will review and compare this report against your September 9, 2011 technical comments to identify any data gaps that still may exist, and along with a summary of Northgate's soil vapor results, will be

included in our Work Plan for Additional Site Assessment. With this additional effort, Stantec is requesting an extension for submittal of this work plan until June 29th.
