Thanks Jerry

I did speak with Mr. Nate Luna with the East Bay Regional Parks District for the encroachment permit on their parcel of land across the street and down gradient of the tanks. I believe that in 2006 Cambria attempted to obtained permission on behalf of Shell, but may have tried with the wrong agency (see except below). Unless you have any additional knowledge on the matter, it appears that the East Bay Parks is the owner and in charge of access, not the State for the parcel of land immediately south of the road. I have their encroachment permit package ready to apply (in addition to the other agency permits for well installation) for once the workplan is submitted to your office and approved.

Based on our review of the previous reports, the sidewalk area seems very problematic to install any additional wells there, the street problematic from a lane closure and continued sampling access efforts. Therefore the land immediately south of the road, down gradient of the former diesel line and between the site and the bay seems the best. Originally a well, S-16, was proposed by Cambia in 2006, but never installed. At this point we can wait for the current groundwater monitor report due to be uploaded by CRA on behalf of Shell to Geotracker on April 30, 2015 to see if there are any significant changes that would materially affect the proposed well placement, and the propose to locate accordingly then and finalize the well installation workplan.

Once the current groundwater data is reviewed as part of the well placement, a workplan for the installation of the down gradient well will be submitted. Below is an excerpt from Cambria June 16, 2006 report which states the difficulty in the down gradient well install as follows:-
