Dear Mr. Goyal and Ms. Wing:

Alameda County Environmental Health (ACEH) staff has reviewed the fuel leak case file for the above-referenced site. In correspondence dated June 22, 2015 (attached), ACEH conditionally approved the scope of work presented in a work plan entitled, "Work Plan for Installation of Two Groundwater Monitoring Wells and to Locate Monitoring Well S-13," dated May 26, 2015. ACEH requested that a report with the results from the proposed scope of work be submitted by October 22, 2015. To date, we have not received a technical report presenting the well installation and sampling results. A technical report presenting these results is a requirement for this fuel leak case. We request that you submit the Well Installation and Sampling Report as soon as feasible but no later than March 12, 2016.

As previously noted in our December 31, 2014 correspondence, AU Energy is the sole responsible party for the September 2013 diesel fuel release. For the September 2013 release, Shell Oil Products does not meet any of the definitions of a responsible party under California Code of Regulations Title 23 Section 2720. Therefore, AU energy is responsible for implementing the investigation and cleanup required as a result of the September 2013 release.

Dear Mr. Goyal and Mr. Pineda:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above-referenced site including the recently submitted document entitled, "Work plan for the installation of two groundwater monitoring wells and to locate monitoring well S-13," dated May 26, 2015 (Work Plan). The Work Plan, which was prepared on behalf of AU Energy LLC by Bureau Veritas North America, presents plans to install two groundwater monitoring wells and to locate well S-13. These activities are necessary to characterize the impact of the September 2013 diesel fuel release on downgradient groundwater quality.

As previously noted in our December 31, 2014 correspondence, AU Energy is the sole responsible party for the September 2013 diesel fuel release. For the September 2013 release, Shell Oil Products does not meet any of the definitions of a responsible party under California Code of Regulations Title 23 Section 2720. Therefore, AU Energy is responsible for implementing the monitoring well installation and sampling.

The Work Plan is conditionally approved and may be implemented provided that the technical comments below are incorporated during the field investigation. Submittal of a revised Work Plan or Work Plan Addendum is not required unless an alternate scope of work outside that described in the Monitoring Plan and technical comments below is proposed. We request that you address the following technical comments, perform the proposed work, and send us the reports described below.

TECHNICAL COMMENTS

1. **Well Screens.** We request that the monitoring wells have screen lengths no greater than 15 feet with the tops of the well screens approximately 2 to 3 feet above the highest historic water levels in order to monitor for possible non-aqueous phase liquid.

2. **Development and Sampling.** We request that the new monitoring wells be developed no sooner than 48 hours after installation. We also request that the new wells be initially sampled at least 72 hours after development to allow groundwater quality within the wells to stabilize and potential non-aqueous phase liquids to accumulate.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please **SWRCB** visit the website for more information on these requirements (http://www.waterboards.ca.gov/water_issues/programs/ust/electronic_submittal/).

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

SUBJECT: Electronic Report Upload (ftp) Instructions

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Please do not submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection.
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the
 document will be secured in compliance with the County's current security standards and a password. <u>Documents</u>
 with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)

Submission Instructions

- 1) Obtain User Name and Password
 - a) Contact the Alameda County Environmental Health Department to obtain a User Name and Password to upload files to the ftp site.
 - i) Send an e-mail to deh.loptoxic@acgov.org
 - b) In the subject line of your request, be sure to include "ftp PASSWORD REQUEST" and in the body of your request, include the Contact Information, Site Addresses, and the Case Numbers (RO# available in Geotracker) you will be posting for.
- 2) Upload Files to the ftp Site
 - a) Using Internet Explorer (IE4+), go to ftp://alcoftp1.acgov.org
 - (i) Note: Netscape, Safari, and Firefox browsers will not open the FTP site as they are NOT being supported at this time.
