Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above-referenced site including the recently submitted document entitled, "Soil & Water Investigation Report with Private Well Status Update," dated December 15, 2008, which was prepared by Broadbent & Associates, Inc. (BAI) for the subject site. BAI installed two borings to assess current soil and groundwater conditions at the former source area and determine the status of previously identified private wells in the area. Soil sample analytical results from the two borings (B-1 and B-2) installed at the site detected TPH-g at a concentration of 0.58 mg/kg in soil sample B-2-14.5 collected at 14.5 feet bgs. Groundwater sample analytical results did not detect concentrations of contaminants above the laboratory detected limit in the "grab" groundwater samples collected from the borings. According to BAI, the private well 17302 VM owner has identified the well as no longer functional. Private well 17372 VM has been identified by the property owner as no longer in existence. No responses from owners of private wells 634H, 642H, and 17348VE regarding the status of their wells were received. Based on the above information, BAI recommends that the site progress towards case closure.

ACEH generally concurs with the BAI's recommendation that the site appears to qualify for closure review and hence will evaluate the case for closure. In the interim, you may suspend quarterly groundwater monitoring at the site. However, please maintain the integrity of the groundwater monitoring wells until the closure evaluation has been completed. You will be notified of the results of the closure evaluation in approximately 6 months.
