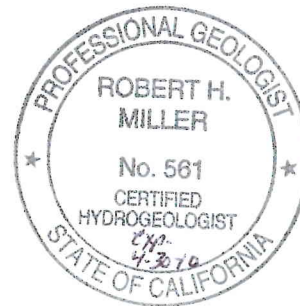

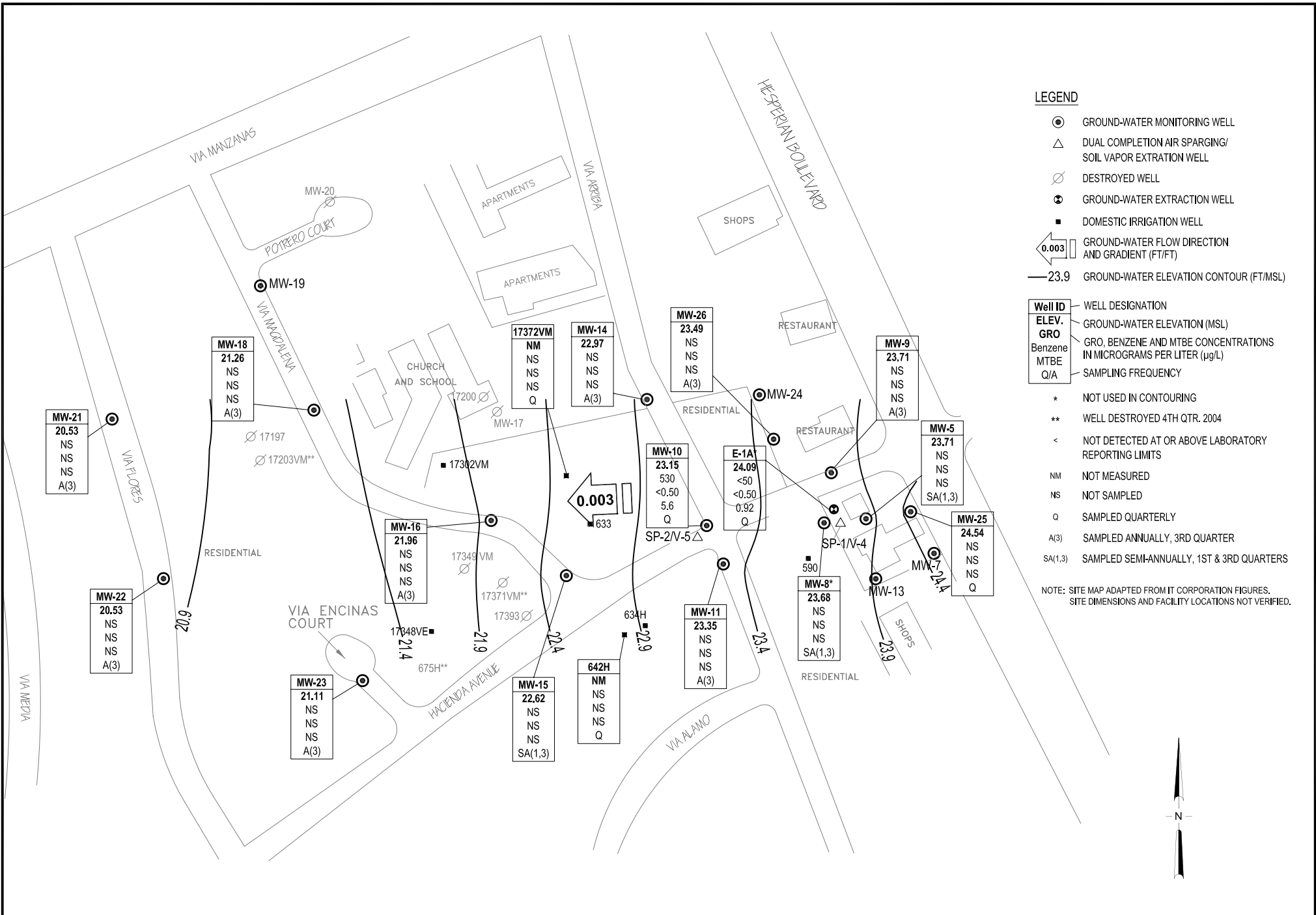

Quarterly ground-water monitoring has been suspended at the Site as dictated in the ACEH letter. BP is currently awaiting a response from ACEH regarding case closure.
