Thank you for calling me earlier this afternoon to discuss this issue. I still find this issue quite sketchy and unusual. To memorialize:

1. You started by saying you agree with the corrective action plan. I asked you for the date and author of this plan and you stated you did not know the property address. Based on this, I asked if you had even read such a plan. You stated you had not read the plan.

2. You then nuanced that you agreed with corrective action. You stated that, as a geologist, you felt the levels of benzene were still too high. I then asked you what harm has been done in the past or will be done in the future. There has been no harm; there will be no harm. I stated this disagreement is not based on science, it appears based on greed.

3. I told you that my client is an engineer and there is no scientific basis to not close out the site. It has been decades and much of this material naturally biodegrades. Nearly two decades and \$200,000 was enough to clean up this site. You admitted groundwater is not pulled from this site and never has been pulled. I pointed out that sites with much higher benzene levels were closed out (even those located in areas where water was supplied from groundwater).

4. We plan to file an action to abate waste of government money and to sue the contractor. As stated, the Courts will be very sympathetic to such an action, even if the State WB is not.

5. You stated that the regs allowed you to refuse a transfer of jurisdiction from Alameda County to your office; yet you refused to provide a citation.

Thank you for taking the time to speak to me this morning on behalf of the State Water Board and Ms. Babcock. We demand this site to be closed and we want it to be closed.
