Dear Dr. Sikand and Mr. Rahman:

I have been recently assigned to your case as the new case worker. Please send all future correspondence or inquiries to my attention. Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above referenced site. Based on a recent ACEH staff review of the case file, we request that you address the following technical comments and send us the reports described below.

TECHNICAL COMMENTS

- 1. Site Conceptual Model The site is the location of a maturing environmental investigation; however, a Site Conceptual Model (SCM) appears to be appropriate based on the recent ACEH review of the case file. The review identified a data gap that requires investigation in order to eliminate future complications as the site draws closer to completion. The intent of the SCM is to identify any additional data gaps that require addressing in order to preclude complications late in the investigation and to position the site for eventual completion. Data gaps identified by ACEH staff include the following:
 - a. Groundwater concentrations in well MW-9 have remained elevated (5,200 micrograms per liter (μg/L) TPHg and 260 μg/L benzene most recently) since initiation of remedial actions, and were elevated in soil bore BH-M located west of the mini mart as of the installation date in January 2006. While the groundwater gradient was recently northwards directed at the site, the flow direction has varied significantly through time at the site. Because the flow has varied widely, defining the lateral extent of the plume will be of import at the site. In particular, but not limited to, the plume remains undefined to the west where a multi-tenant residential building is present. It appears appropriate to define the lateral extent of the contaminant plume to preclude potential health risks to vicinity residents.

As you may be aware, an SCM is a set of working hypotheses pertaining to all aspects of the contaminant release, including site geology, hydrogeology, release history, residual and dissolved contamination, attenuation mechanisms, pathways to nearby receptors, and likely magnitude of potential impacts to receptors. The SCM is used to identify data gaps that are subsequently filled as the investigation proceeds. As the data gaps are filled, the working hypotheses are modified, and the overall SCM is refined and strengthened. Subsurface investigations continue until the SCM no longer changes as new data are collected. While usable aspects of an SCM have been included in previous reports, at a minimum, the SCM should include:

- (1) Local and regional plan view maps that illustrate the location of sources (former facilities, piping, tanks, etc.) extent of contamination, direction and rate of groundwater flow, potential preferential pathways, and locations of receptors;
- (2) A minimum of two geologic cross section maps (downgradient and gradient parallel) that illustrate subsurface features, man-made conduits, and lateral and vertical extent of contamination;
- (3) Plots of chemical concentrations versus distance from the source;
- (4) Summary tables of chemical concentrations in different media (i.e. soil, groundwater, and soil vapor); and
- (5) Discussion of likely contaminant fate and transport.

If data gaps (i.e. potential contaminant volatilization to indoor air or contaminant migration along preferential pathways, etc.) are identified in the SCM, please include a work plan to address those data gaps.

2. Vapor Sampling - Vapor samples collected immediately before and shortly after system startup indicated that elevated soil vapor concentrations were present below the United Transmission building at a depth of 2 feet. Two subsequent sampling events yielded substantially lower, but still elevated, concentrations and also did not indicate ozone infiltration into the buildings from the ozone sparging system. It has been over approximately 2.5 years since this issue has been revisited, and it would be appropriate to verify this remains a sound working assumption for the site and for workers in both buildings. Please incorporate this request in the data gap work plan requested below.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

REQUIREMENTS

- Please do not submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection.
- It is **preferable** that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the document will be secured in compliance with the County's current security standards and a password.
 <u>Documents with password protection will not be accepted.</u>
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
