Dear Mr. Razi:

Alameda County Environmental Health (ACEH) staff has reviewed the fuel leak case file for the above-referenced site including the most recently submitted document entitled, "*Third Quarter 2009 Groundwater Monitoring and Remediation System Operation Report with Evaluation of Effectiveness of Monthly MPE*," dated October 28, 2009 (Report). The Report, which was prepared on your behalf by SOMA Environmental Engineering, Inc., presents the results from a quarterly groundwater monitoring event and a multi-phase extraction (MPE) event in September 2009.

The Report concludes that implementation of MPE has been effective in reducing contaminant concentrations at the site and requests that the site be considered for case closure. Based upon our review of the most recent reports and case file, case closure cannot be considered until the potential for vapor intrusion to the adjacent building to the southwest is evaluated as discussed in technical comment 1 below. We request that you submit a Work Plan to collect data to confirm that the petroleum hydrocarbons detected in soil vapor southwest of the site do not pose a risk of intrusion to indoor air for the existing apartment building on the adjacent property to the southwest.

We request that you address the following technical comments, perform the proposed work, and send us the reports described below.

#### **TECHNICAL COMMENTS**

1. **Potential for Vapor Intrusion.** On November 14, 2008, four soil vapor samples (SV-2 through SV-5) were collected adjacent to the apartment building located southwest of the site. Total petroleum hydrocarbons as gasoline (TPHg) were detected in each of the four soil vapor samples at concentrations ranging from 8,400 to 75,000 micrograms per cubic meter ( $\mu\text{g}/\text{m}^3$ ). The concentration of TPHg in soil vapor exceeded the Environmental Screening Level (ESL) for residential land use of  $10,000 \mu\text{g}/\text{m}^3$  (San Francisco Bay Regional Water Quality Control Board May 2008) in three of the four soil vapor samples collected. Benzene was detected in the soil vapor samples at concentrations ranging from 12 to  $78 \mu\text{g}/\text{m}^3$ . All of the analytical results for benzene were less than the ESL for residential land use of  $84 \mu\text{g}/\text{m}^3$ . Subsequent to the November 14, 2008, several MPE events were conducted at the site including MPE events that utilized monitoring well MW-8, which is located in the southwestern portion of the site. In order to assess whether the TPHg detected in soil vapor in November 2008 poses a risk for vapor intrusion, we request that you conduct additional soil vapor sampling. Please submit a Work Plan that proposes soil vapor sampling adjacent to or beneath the

apartment building. Collection of vapor samples from the subslab of the building would be the most direct method to assess the potential for vapor intrusion.

2. **Groundwater Extraction and Monitoring.** We request that the groundwater extraction system be shut down at this time to allow equilibrium conditions to be established prior to soil vapor sampling. Groundwater monitoring may also be suspended at this time.

### **TECHNICAL REPORT REQUEST**

Please submit technical reports to Alameda County Environmental Health (Attention: Jerry Wickham), according to the following schedule:

- **March 29, 2010** – Work Plan

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

### **ELECTRONIC SUBMITTAL OF REPORTS**

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) Geotracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the Geotracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in Geotracker (in PDF format). ### **PERJURY STATEMENT**

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

## PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

## UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

## AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

#### REQUIREMENTS

- Entire report including cover letter must be submitted to the ftp site as a **single portable document format (PDF) with no password protection**. (Please do not submit reports as attachments to electronic mail.)
- It is **preferable** that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements **must** be included and have either original or electronic signature.
- **Do not password protect the document**. Once indexed and inserted into the correct electronic case file, the document will be secured in compliance with the County's current security standards and a password. **Documents with password protection will not be accepted.**
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:  
RO#\_Report Name\_Year-Month-Date (e.g., RO#5555\_WorkPlan\_2005-06-14)

#### Additional Recommendations

- A separate copy of the tables in the document should be submitted by e-mail to your Caseworker in **Excel** format. These are for use by assigned Caseworker only.

#### Submission Instructions

- 1) Obtain User Name and Password:
  - a) Contact the Alameda County Environmental Health Department to obtain a User Name and Password to upload files to the ftp site.
