Eric,

In reviewing possible alternate downgradient well locations, I noticed that there were two fuel leak sites with active groundwater monitoring further downgradient from your proposed well location. The sites are a former Chevron at the corner of 17th and Harrison (1633 Harrison) and a Douglas Parking site at 1721 Webster. Although these sites are further from the site than the proposed well location, data from the upgradient wells at these sites may help define plume extent. Have you looked at the potential to use the upgradient wells at these sites to establish plume boundaries for your site?

Dear Jerry Wickham,

We have been in contact with Brian Booth of the Marian E. Booth Trust to grant us access to the adjacent Douglas Parking lot (1515 Harrison Street). I have had discussions with him and David Douglas at Douglas Parking. Even after your letter dated May 6, 2009, Mr. Booth has called me to deny access on the property in order to install the proposed monitoring well. At this time, we have been denied the necessary access agreement needed to install the down gradient monitoring well, and do not have an alternate location identified. We would like to discuss the options and alternatives with you as soon as possible.

Also, we are still waiting to finalize the Encroachment permit from the City of Oakland. We completed the encroachment package, paid, and submitted it for approval. The permit has finally been processed; however, we are sorting out an issue as one of the trustees listed on the property title and encroachment permit has since passed away. We have continually been working with the City of Oakland Permitting department and our client to get the paperwork corrected and finalized. We are not certain as to how soon we can expect to get the permit activated.

We are working as diligently as we can on getting this field work implemented and hope to sort out these hold ups as soon as possible, as the current report submittal deadline is June 30, 2009.
