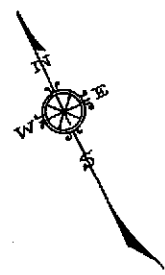
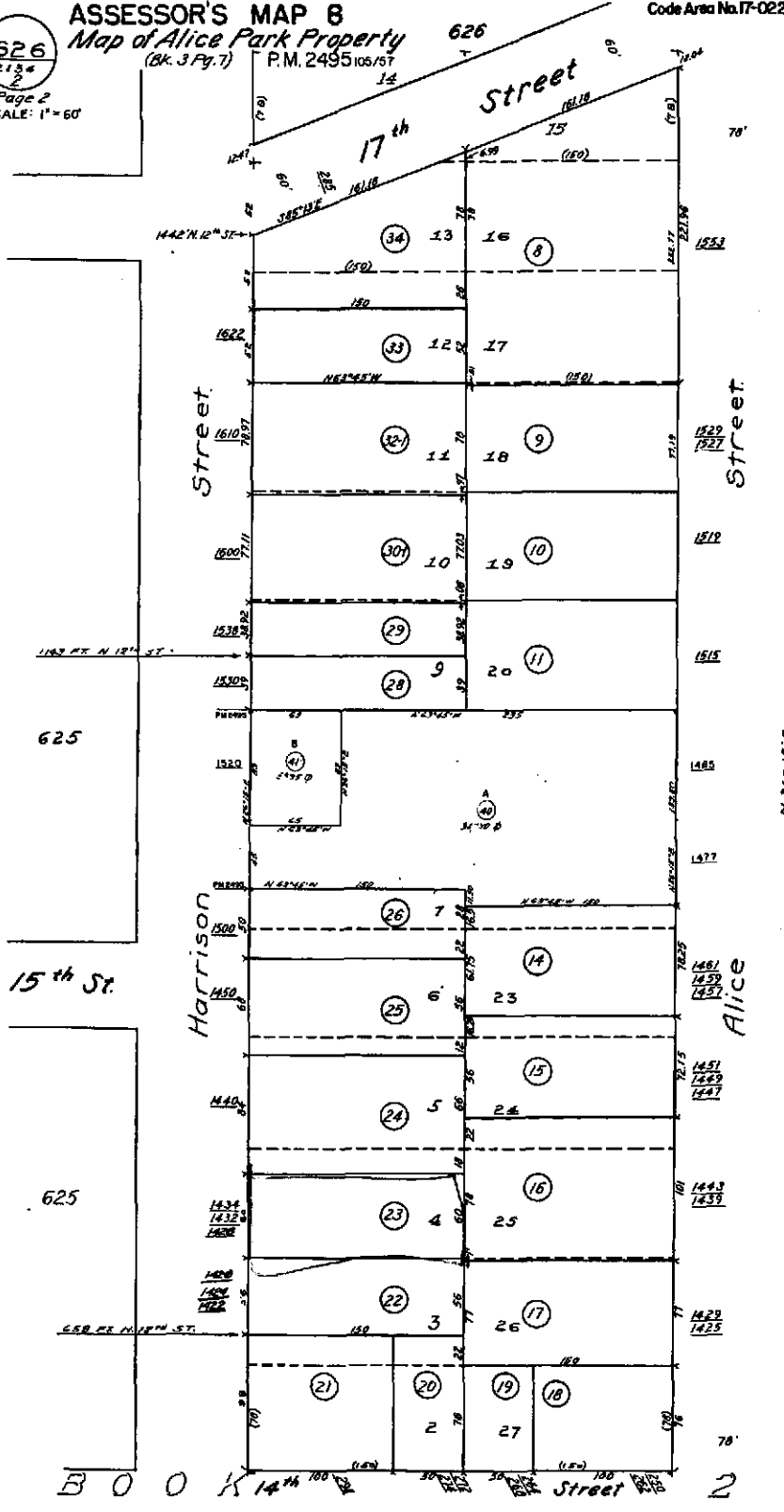


ASSESSOR'S MAP 8
