Alameda County Department of Environmental Health (ACDEH) requested a follow up investigation for the subject fuel leak case earlier this year. A part of the investigation included sampling existing off-site soil vapor probes, one of which is located on your property. ACDEH understands that Golden Empire Properties representative (Responsible Party for the subject Fuel Release Case) and/or representatives of his consultant, Weber, Hayes & Associates, (Pat Hoban, Craig Drizin), have requested access to your property at 3014 Bartlett Street in Oakland earlier this year but access to your property was refused. The purpose of the access request was to recover a soil vapor sample from a vapor probe that was installed in 2008 as part of a subsurface investigation for the subject case.

The subject case may be nearing closure consideration. Therefore, ACDEH has again requested the Responsible Party and his consultant to attempt to resample the existing vapor probe located on your property. The vapor probe was installed following a 2007 investigation which included advancing a soil bore at your property. In order to reevaluate the site conditions from the 2007/2008 investigations, our agency has also requested a temporary soil bore be advanced for the collection of additional soil samples to aid in our case closure consideration. The soil bore will be advanced using minimally disruptive techniques.

ACDEH requests that you cooperate with Responsible Party and his consultant by allowing them access to perform the work requested by our agency. Thank you for your cooperation.
