

Dear Ms. Brown:

This report fulfills quarterly requirements established by EBMUD for discharge of groundwater to the sewer main at the above-referenced site.

On April 3, 2013, SOMA received approval from San Francisco Bay Regional Water Quality Control Board to conduct multi-phase extraction (MPE) pilot testing at the site. MPE pilot test will utilize on-site groundwater monitoring and remediation wells to extract contaminated soil vapor and groundwater, treat it and discharge to the sewer. EBMUD issued a Special Discharge Permit (SDP) upon SOMA's request, effective August 4, 2013.

However, SOMA has not conducted the MPE pilots test as of this date, pending receipt of permit to operate from the Bay Area Air Quality Management District (BAAQMD). Therefore, no groundwater has been extracted, treated or discharged to the sewer system during the reporting period of July through September 2013.

The groundwater extracted during the MPE pilot test and any future MPE events will be treated through groundwater treatment system consisting of two units of granular activated carbon (GAC) connected in series. Each unit is a 55 gallon tank filled with 200 lb of coconut husk charcoal. Treated groundwater will then be discharged to the EBMUD sewer system.

Upon commencement of MPE pilot testing at the site, all discharge will be totalized and operation and maintenance logs will be maintained and submitted to EBMUD as required in the SDP conditions.
