Dear Mr. Badetscher,

It was a pleasure meeting with you and Ms. Charlene Neely this morning at our office. As a recap of our meeting we discussed the two remaining data gaps identified in Alameda County Environmental Health's (ACEH) most recent Directive letter dated November 7, 2014. The remaining data gaps are:

- 1. Sensitive Receptors, and
- 2. Preferential Pathways.

In an effort to move this case toward closure, ACEH contacted Alameda County Public Works Agency (ACPWA) to supplement the well search previously performed using the Department of Water Resources (DWR) database search. Based on a review of the of the well search results for both the ACPWA and DWR, there does not appear to be sensitive receptors that would be impacted by the residual contamination at the site.

On December 5, 2014, ACEH sent an email to the City of Oakland Public Works (OPW) to address the preferential pathways issue. ACEH hopes to receive a response to our information request in the near future. The response from OPW will determine whether not additional work needs to be performed.

As requested in the meeting, ACEH has provided the List of Landowners form as an attachment.
