Dear Ladies and Gentlemen:

It has become apparent that a fairly complex interplay of events involving the conversion of a gasoline underground storage tank (UST) to a diesel UST on October 29, 2009, and the subsequent detection of diesel Light Non-Aqueous Phase Liquids (LNAPL) in well RW-1 in July 2011, and the removal of a waste oil UST on September 6, 2013, and the detection of diesel- and oil-range LNAPL in the waste oil UST excavation pit on September 6, 2013, has occurred which involves multiple Responsible Parties at the site. This has complicated the case closure request for the site. It appears appropriate to request specific site details in order for ACEH to determine the appropriateness of the closure request by Arco, versus the appropriateness of case closure for Arco and the opening of a new case with DDJ Property Holdings, Inc and Delong Oil, Inc. as remaining primary Responsible Parties at the site.

In order for ACEH to make a determination on RP status for the diesel and motor oil contamination at the site we request that each of you address the following technical comments and submit the documents as requested and described below. Subsequent to the submittal of these documents, ACEH would like to convene a meeting with all parties, on the date identified below. Please place this date in your calendars or immediately notify ACEH that the date is not workable for you.

TECHNICAL COMMENTS

1. Timeline of Property Ownership and Tank Ownership at the Site – One of the keys to understanding the diesel and waste oil groundwater contamination at the site appears to be a timeline of the complete history of the two USTs from installation, including conversion history, tank ownership history, and property ownership history.

Please enhance this timeline by incorporating historic diesel usage and waste oil storage at the site, reported detections of diesel- and oil-range hydrocarbons in soil and groundwater, and any other information pertinent to resolving these issues.

2. Diesel Source Evaluation – A second key to the site is to understand the location of the diesel dispensing infrastructure and the location of the possible sources of diesel detections in soil and groundwater. The location of diesel related infrastructure has not been reported, other than the presence of a diesel UST at the site. Please prepare a figure depicting the location of the diesel dispenser(s), product piping, and tank on site plans. Please include the locations of soil and

groundwater where diesel hydrocarbon contamination has been detected on the figure showing the site infrastructure.

- 3. Waste Oil Source Evaluation A third key to the site is to understand the location of the waste oil infrastructure (product lines and tank location), and the location of the possible sources of oil hydrocarbon detections in soil and groundwater. At present only the location of the former waste oil UST has been reported. Please prepare a figure depicting the location of the waste oil infrastructure on site plans. Please include the locations of soil and groundwater where oil-range hydrocarbon contamination has been detected on the figure showing the site infrastructure.
- 4. Evaluation of Current Site Conditions Please evaluate and report on the current condition of all site wells, including current well integrity during site redevelopment, the status of redevelopment, and the current UST system configuration, including the status of CUPA permits. Please also review the current groundwater monitoring schedule for appropriateness to capture adequately representative concentrations and free-phase thicknesses of diesel and waste oil contamination.

TECHNICAL REPORT REQUEST

Please upload technical reports to the ACEH ftp site (Attention: Mark Detterman), and to the State Water Resources Control Board's Geotracker website, in accordance with the specified file naming convention below, according to the following schedule:

- May 23, 2014 Timeline, Diesel and Waste Oil Source Evaluation, and Current Site Conditions File to be named: MISC_R_yyyy-mm-dd
- June 6, 2014 Stakeholder Meeting

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

Responsible Party(ies) Legal Requirements/Obligations

REPORT/DATA REQUESTS

These reports/data are being requested pursuant to Division 7 of the California Water Code (Water Quality), Chapter 6.7 of Division 20 of the California Health and Safety Code (Underground Storage of Hazardous Substances), and Chapter 16 of Division 3 of Title 23 of the California Code of Regulations (Underground Storage Tank Regulations).

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (Local Oversight Program [LOP] for unauthorized releases from petroleum Underground Storage Tanks [USTs], and Site Cleanup Program [SCP] for unauthorized releases of non-petroleum hazardous substances) require submission of reports in electronic format pursuant to Chapter 3 of Division 7, Sections 13195 and 13197.5 of the California Water Code, and Chapter 30, Articles 1 and 2, Sections 3890 to 3895 of Division 3 of Title 23 of the California Code of Regulations (23 CCR). Instructions for submission of electronic documents to the ACEH FTP site are provided on the attached "Electronic Report Upload Instructions."

Submission of reports to the ACEH FTP site is in addition to requirements for electronic submittal of information (ESI) to the State Water Resources Control Board's (SWRCB) Geotracker website. In April 2001, the SWRCB adopted 23 CCR, Division 3, Chapter 16, Article 12, Sections 2729 and 2729.1 (Electronic Submission of Laboratory Data for UST Reports). Article 12 required electronic submittal of analytical laboratory data submitted in a report to a regulatory agency (effective September 1, 2001), and surveyed locations (latitude, longitude and elevation) of groundwater monitoring wells (effective January 1, 2002) in Electronic Deliverable Format (EDF) to Geotracker. Article 12 was subsequently repealed in 2004 and replaced with Article 30 (Electronic Submittal of Information) which expanded the ESI requirements to include electronic submittal of any report or data required by a regulatory agency from a cleanup site. The expanded ESI submittal requirements for petroleum UST sites subject to the requirements of 23 CCR, Division, 3, Chapter 16, Article 11, became effective December 16, 2004. All other electronic submittals required pursuant to Chapter 30 became effective January 1, 2005. PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 7835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, late reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

The Alameda County Environmental Cleanup Oversight Programs (petroleum UST and SCP) require submission of all reports in electronic form to the county's FTP site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Please <u>do not</u> submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single Portable Document Format (PDF) with no password protection.
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the document will be secured in compliance with the County's current security standards and a password.
 Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)

Submission Instructions

- 1) Obtain User Name and Password
 - a) Contact the Alameda County Environmental Health Department to obtain a User Name and Password to upload files to the ftp site.

- b) In the subject line of your request, be sure to include "ftp PASSWORD REQUEST" and in the body of your request, include the Contact Information, Site Addresses, and the Case Numbers (RO# available in Geotracker) you will be posting for.
- 2) Upload Files to the ftp Site
 - a) Using Internet Explorer (IE4+), go to http://alcoftp1.acgov.org
 - (i) Note: Netscape, Safari, and Firefox browsers will not open the FTP site as they are NOT being supported at this time.
 - b) Click on Page located on the Command bar on upper right side of window, and then scroll down to Open FTP Site in Windows Explorer.
 - c) Enter your User Name and Password. (Note: Both are Case Sensitive.)
 - d) Open "My Computer" on your computer and navigate to the file(s) you wish to upload to the ftp site.
 - e) With both "My Computer" and the ftp site open in separate windows, drag and drop the file(s) from "My Computer" to the ftp window.

 - d) If your document meets the above requirements and you follow the submission instructions, you will receive a notification by email indicating that your document was successfully uploaded to the ftp site.
