I do understand potential problems with offsite access; however, site work has already received an extension for the vapor intrusion issue (from July 15). If you believe additional time may be useful, then let's observe an extension to October 31. If you believe it would be useful to get ACEH involved to help obtain access, please do let me know. If any of the buildings have tenants then the owners may potentially be exposing occupants to hydrocarbon vapors. This should be kept moving due to that possibility.

Due to the delays in vapor intrusion access the soil and groundwater report date will need to be extended. Let's revisit that once you achieve some resolution on offsite access.
