Ann Conner of PGE tells me that they have claimed the GeoTracker case (T0600101667) and that one or two documents have been uploaded to the Geotracker website to document this and to help clarify available information. Because ACEH is no longer associated with the case we cannot enter the regulator side of the website to approve the documents or to indicate the date of action, then available to the public side of the website. While it is understood that DTSC uses the Envirostor website, it may be appropriate for DTSC to update the Geotracker case to reflect these actions. We've been in the process of cleaning up GeoTracker as a part of the Resolution 2009-0042 review process and found that a Voluntary Cleanup Agreement was signed on December 21, 2009 for the PGE Subarea of Case # 01490011. It appeared reasonable to transfer oversight of ACEH Case RO 286 at the site to DTSC, and this was done on March 12th.

Please be aware that a UST at the southern end of the area covered by the VCA is NOT depicted on the Site Diagram (Exhibit B; Building A 4227 Hollis St). It is our recommendation that issues associated with this UST be included in your oversight in order to eliminate potential complications in the future. Information and historic reports concerning this UST, and on the other two areas investigated with ACEH oversight can be found on the ACEH web database under the referenced case number. A link can be found below. You can determine the location of the UST missing from Exhibit B in a report labeled SWI_R_1999-07-19. Additional UST removal information can be found beginning on page 245 of the CORRES file (to about the end; however, I wouldn't limit myself to just these two files). The 1999 report also has information on the USTs removed just north of 45th Street, which appear on Exhibit B. If you have not reviewed these reports, you may find them useful.
