I wanted to follow up with you on the monitoring plan ARCADIS submitted last week for the City of Oakland Municipal Service Center, located at 7101 Edgewater Drive, Oakland, California. A quarterly monitoring schedule was proposed based on recommendations in the November 3, 2011 Alameda County Environmental Health Services (ACEHS) comment letter and conversations between Mr. Gopal Nair (City of Oakland) and you on November 4, 2011.

Since we conducted our standard annual monitoring event in the third quarter of 2011 (September 2011), we would like to sample this week to capture results for the fourth quarter of 2011. I attempted to contact you Monday, but received your out of office message. Although we do not want to make any moves without approval from the ACEHS, we do want to conduct a quarterly monitoring event in the month of December. Unfortunately I cannot get anybody out to the site the last week of December so this week is my only opportunity.

Even though we are not waiting on an approval from ACEHS before conducting this next quarterly sampling event, we feel you will be in agreement with our approach as we have selected wells that will monitor the potential for off-site contaminant migration, as well as representative wells from each onsite TPH plume.
