This email is in response to your letter dated October 4, 2017 (attached), regarding the City of Oakland Municipal Service Center site at 7101 Edgewater Drive, Oakland (case RO0000293). This email is to confirm acceptance of Technical Comment 2 (pg. 2), in which ACDEH recommended an additional MIP bore location be advanced between proposed locations MIP-10 and MIP-14. Terraphase, on behalf of the City of Oakland, concurs with this recommendation, and will include this in our scope of work for the proposed investigation.
