As discussed in today's meeting, lets plan on scheduling a meeting in August after you have collected another round of groundwater sampling results and have digested some of the information we discussed today including addressing the high benzene concentrations in wells, validating the monitoring well network with respect to producing valid concentration data and free product observations, updating the risk assessment to include the May 2013 ESLs, synthesizing the soil data to address the fill issues, potential rebound in wells where ozone has been injected, and plume length delineation.
