Dear Mr. Hill:

This is a referral case for the subject site. The site Responsible Party continues to delineate and monitor the area of contamination. The site has had free phase product. Alameda County Environmental Health (ACEH) is referring this site to the San Francisco Bay Regional Water Quality Control Board for continuing site remediation activities.

Site Background

Underground storage tanks (USTs) were removed from the subject site in 1987 and 2005. Free phase product was observed in the sump pits during the 1987 removal activities. Concentrations of total petroleum hydrocarbons (TPH) as oil were reported up to 13,000 milligrams per kilogram (mg/kg) and 34,000 mg/kg total oil and grease in soil. TPH concentrations in groundwater were reported up to 290,000 micrograms per liter (μ g/L) and 13,000 μ g/L benzene. The November/December, 2011 groundwater sampling event documented concentrations of TPH as gasoline and as diesel up to 37,000 μ g/L and 10,700 μ g/L, respectively, and benzene up to 11,100 μ g/L.
