Ladies and Gentlemen:

In accordance with the March 15, 2013 letter from your office, this workplan addendum provides requested additional workplan elements for the Albany Fire Station underground storage tank site (Site) located at 1001 Marin Avenue in Albany, California (see Figure 1 and Figure 2). This workplan addendum includes: (1) A revised Figure 2; and (2) Requested modifications to the workplan.

In order to assess potential hydrocarbon impacts in an expected downgradient (southwest) groundwater flow direction, IB-4 will be sited approximately 35 feet southwest from the former Site UST (see Figure 2).

Soil samples will be collected for laboratory analysis at five-foot intervals and at changes in lithology, obvious signs of hydrocarbon impacts (based on field screening results), and immediately above the groundwater (if possible). Also, the boring logs for the two proposed borings will include PID readings and, if possible, first and stabilized groundwater depths in the borings.

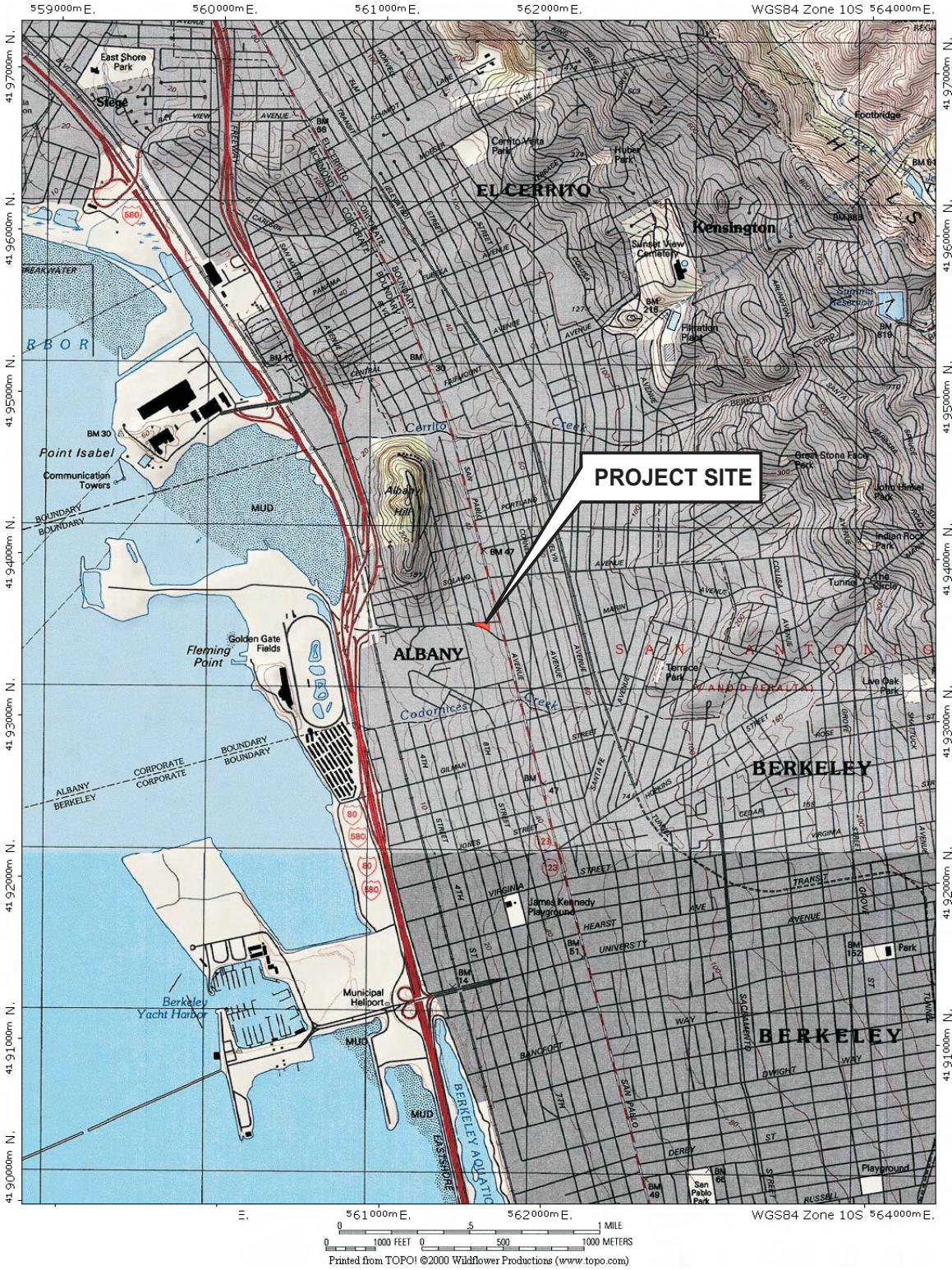

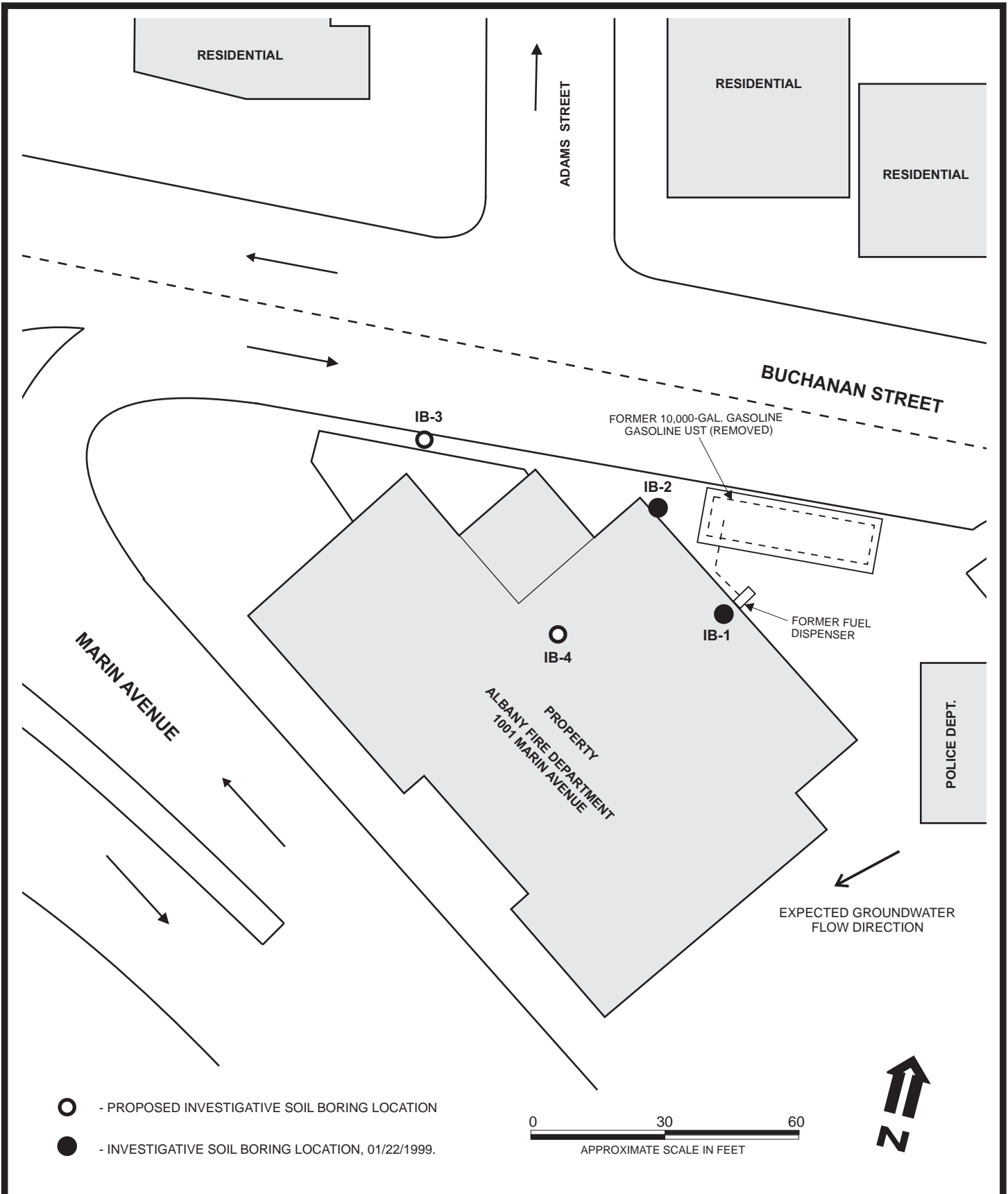
**SITE VICINITY MAP**
