Hello Paresh,

This email is in response to your letter from ACEH dated 4/8/2009 regarding former BP Station #11266 at 1541 Park Street, Alameda, California (ACEH Case #RO0000318). Specifically this email requests an extension of the 7/7/2009 due date for submittal of the Soil & Ground-Water Investigation Report containing source area verification sampling results.

Stratus Environmental Inc. (Stratus) completed hand-auger boring investigation activities onsite on 6/10/2009. BAI has not received the data package for this field work yet. Stratus did begin preliminary activities preceding field work as soon as authorized by BAI, however as you may recall there was a delay concerning whether a boring could be attempted in the area around former sample C-1. In addition, since the site had never been properly surveyed to NAD'83/NAVD'88, a new site survey was commissioned. However we have since learned from Stratus that Wood Rodgers Inc. is redoing the survey due to found errors in their work. BAI anticipates receipt of the hand-auger boring investigation field work data package and new survey data package from Stratus within the next week or so. In addition, the existing monitoring wells associated with the Site were re-sampled on 6/25/2009 in accordance with your 4/8/2009 directive letter. We have not received the data package for this field work yet but anticipate it within the next week or so.

Due to the above justifiable reasons, BAI proposes combining the hand-auger boring Soil & Ground-Water Investigation Report with the one-time 2Q09 Ground-Water Monitoring Report and submitting them as one combined report by no later than 8/7/2009. This would be within the timeline originally requested in your 4/8/2009 letter for the 2Q09 Ground-Water Monitoring Report, specifically within 45-days following sample collection. During our telephone conversation yesterday you seemed receptive to this extension request.

The favor of a written email reply approving this extension request for the report(s) to 8/7/2009 would be greatly appreciated.
