Dear Mr. Hill:

This is a notice of an enforcement referral for the subject site. Site Responsible Parties are non-responsive to Alameda County Environmental Health (ACEH) requests and are recalcitrant. The site has accumulated a series of Notice of Violations from ACEH. As a consequence, ACEH is referring this site to the San Francisco Bay Regional Water Quality Control Board for enforcement actions.

## Site Background

One 8,000-gallon diesel UST and one 8,000-gallon gasoline UST were removed from the site. Four holes with a maximum diameter of ½-inch were observed in the gasoline UST. Contaminated soil and possibly free product remains in the area of the former USTs. The extent of groundwater contamination has not been defined to the west and north and may extend off-site. In addition, further work is needed to confirm that no water supply wells are located downgradient from the site.

Notices of Violation were October 5, 1998, February 26, 1999, April 13, 2000, May 1, 2000, and September 13, 2000. The Responsible Party did not comply with an ACEH directive letter dated October 4, 2010 that requested a Work Plan and groundwater sampling.
