Thank you for the letter dated March 11, 2010 (received March 24, 2010), wherein you have notified ACEH of your intent to proceed with remediation as proposed in the remedial work plan dated October 30, 2009. It is understand that this is being done under 23 CCR S 2722(e), and that the contamination is impairing its ability to obtain financing and sell the property. Please be advised that the SWRCB has mandated (Resolution 2009-0042) that no directive letters can be completed until all sites have undergone a Closure Review for Geotracker, except under limited conditions which this site does not appear to meet (imminent health risk or jeopardy to stimulus funding). That period for review of cases will be closing shortly; however, the mandate has precluded ACEH from comprehensively reviewing the remedial work plan and issuing a directive letter. Please be advised that should you continue to proceed with the work, you would be doing so without concurrence from ACEH. If no comments arise from the review of the remedial work plan, then proceeding with the work would not appear to have significant repercussions. However, if comments to the work plan are identified, modifications to the work may be necessary, which may require additional mobilizations and /or additional sample analyses, etc. Please note that the UST Cleanup Fund typically reimburses costs for a scope of work that has been approved by a regulatory agency. Since a review of the work plan could not be completed in the standard 60 day time frame allotted and if the scope of work is implemented prior to regulatory approval, the UST Cleanup Fund may not fully reimburse all costs associated with the proposed scope of work. Please contact the UST Cleanup Fund to address any cost reimbursement concerns.
