Hi Mark,

Please accept this e-mail as a formal request for an extension to the ACEH requirement of a groundwater sampling report due May 16, 2014. At our April 22, 2014 meeting, you indicated that it would be appropriate to postpone the groundwater sampling event until after we have installed the new monitoring well along the southern boundary of the site. SGI has just received a new contract from our client. We are initiating the well permitting and driller contracting process immediately.

Upon completion of the well installation work, we will conduct the site-wide groundwater monitoring event. In addition, we are finalizing the revised responses to ACEH comments on the Remedial Investigation Report and will submit to you upon completion.
