We are counsel for Fatih and Ferda Tekin, and we are in receipt of your letter dated March 28, 2008. Please excuse the delayed response. The correct address for Mr. and Mrs. Tekin is 121 Diamond Court, Hercules, CA 94547, and it took some time for your letter to reach them. Mr. Tekin was also out of the country recently.

Mr. and Mrs. Tekin are the current owners of the property. They purchased the property in 2003, and the seller agreed to indemnify them against any claims related to contamination of the property and agreed to handle all the remediation efforts. Funds are held in escrow for that purpose.


