In correspondence dated July 7, 2006, ACEH requested implementation of the DPE system proposed in Cambria Environmental Technology, Inc's Feasibility Study and Corrective Action Report dated June 14, 2006. Project implementation was delayed and the latest extension to install the system was extended to August 21, 2010 per your e-mail dated July 30, 2010.
