Project update: per the January 7, 2016 directive letter from ACEH, we have conducted almost all tasks and have actually updated the SCM, but have had a little difficulty gaining access to the west adjacent drainage channel (to survey channel bottom elevations relative to well TOC elevations). However, we were finally able to find the right person at Zone 7 (they apparently manage the channel, which is a restricted access area) and are currently processing an encroachment permit application for a one time entry to the channel area.
